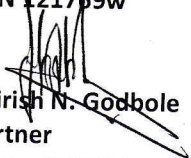
Emphasis of Matter

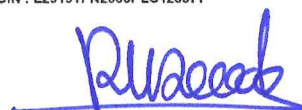
