Pursuant to the provisions of Regulation 30 read with sub-para 4, Para B, Part A, Schedule III of the SEBI (Listing Obligations and Disclosure Requirements), Regulations 2015 (Listing Regulations), we hereby inform that the Company has received an order worth Rs. 19.16 Crore from Mazagon Dock Shipbuilders Ltd (MDL) for the supply of turnkey HVAC solutions onboard 14 Fast Patrol Vessels (FPVs) for the Indian Coast Guard.

This development follows the recent order of Rs. 106.62 Crore awarded to SRL on 25th August 2025 by Hindustan Shipyard Ltd (HSL) for HVAC solutions for five Fleet Support Ships (FSS) of the Indian Navy.

Further, it is hereby informed that the Company is also executing a similar FPV project with Goa Shipyard Ltd (GSL) for 8 vessels, with the first ship already delivered to the Coast Guard.

These consecutive wins underscore SRL's strong capabilities in delivering end-to-end HVAC solutions for defence and marine platforms, reinforcing its position as a trusted partner in India's shipbuilding and maritime security ecosystem.
