The Shree Refrigerations Limited (SRL) is pleased to announce that it has recently secured Rs. 25.60 Crore order from Mazagon Dock Shipbuilders Limited (MDL) for the supply of B&D spares for AC Plants onboard P17A class ships. Alongside this, SRL has also received:

- Rs. 19.62 Crore Supply of Turnkey HVAC system as per SOTR, from Mazagon Dock Shipbuilders Limited (MDL);
- Rs. 4.12 Crore Supply of Magnetic Bearing Compressor based AC Plant, from Material Organisation, Mumbai.

Together, these new orders add Rs. 49.34 Crore to SRL's order book.
