Pursuant to the provisions of Regulation 30 read with sub-para 4, Para B, Part A, Schedule III of the SEBI (Listing Obligations and Disclosure Requirements), Regulations 2015 (Listing Regulations), we hereby inform you as follows:

The Shree Refrigerations Limited (SRL) is pleased to announce that it has recently secured Rs. 25.60 Crore order from Mazagon Dock Shipbuilders Limited (MDL) for the supply of B&D spares for AC Plants onboard P17A class ships. Alongside this, SRL has also received:

- Rs. 19.62 Crore – Supply of Turnkey HVAC system as per SOTR, from Mazagon Dock Shipbuilders Limited (MDL);
- Rs. 4.12 Crore – Supply of Magnetic Bearing Compressor - based AC Plant, from Material Organisation, Mumbai.

Together, these new orders add Rs. 49.34 Crore to SRL's order book.

This was shortly preceded by a landmark Rs. 106.62 Crore contract awarded on 25<sup>th</sup> August 2025 by Hindustan Shipyard Ltd (HSL) for HVAC solutions for 5 Fleet Support Ships (FSS) of the Indian Navy.
